We are writing to inform you of planned work to replace aging natural gas pipelines in the area of 5th Avenue in Downtown Kenai between Evergreen Street and Floatplane Road, south to Kenai Avenue. Our records indicate that you have an ENSTAR account address located within this impacted area.

The purpose of the project is to replace aging natural gas pipelines that are approaching 70 years. Aging pipelines are susceptible to leaks and damage from earthquakes and freezing/thawing ground. We are replacing these pipelines to make sure we continue to provide safe and reliable natural gas service for decades to come.

The work will happen in two main phases:


- End of March April, 2024, ENSTAR will begin moving gas meters to ensure they are properly located and fitted to connect to the new piping. In some cases, we will replace meters. If your meter is moved or replaced, you will receive a door tag indicating ENSTAR was at your property to perform work.
- Mid-May Early August, 2024: Construction work to replace existing piping.
  While we do not anticipate road closures, traffic may be congested at times.
  During this period, please refrain from parking on the street. This ensures that our crews work as quickly as possible and avoid prolonged disruption in the area.
- You may also notice ENSTAR work in or around your yard to replace service lines which feed gas from the natural gas "main" pipeline to your meter. Any disturbed ground will be restored and reseeded as needed to return property to its previous condition.
